Kansas Helping Empower and Recover Together
(KS-HEART): Family Centered Treatment for
Pregnant and Post-Partum Women

DCCCA-Women's Recovery Center is pleased to announce KS-HEART, a yearlong family centered approach to substance use treatment and recovery for pregnant and parenting women in Sedgwick and surrounding counties. Family involvement is a key component of sustainable recovery and KS-HEART actively engages those who women identify as family in this program. Substance use treatment and family therapy is augmented by Peer Support, case management, parenting, coordinated community-based support services, employment and housing readiness, barrier reduction funds and comprehensive screening and referral for a woman's children. Services are offered at Women's Recovery Center, in the family home and throughout the community.

ELIGIBILITY REQUIREMENTS

- Pregnant or within one-year post-partum.
- A diagnosed substance use disorder.
- Reside in Sedgwick County. Referrals from contiguous counties will be accepted on a case-by-case basis.
- Voluntarily consent to participate in KS-HEART and identify at least one person to participate in family services.
- Mothers do not need to have their children in their custody to participate.

DO YOU OR SOMEONE YOU KNOW NEED HELP WITH SUBSTANCE ABUSE?

CONTACT WOMEN'S RECOVERY CENTER. A licensed therapist will guide the individual through an assessment to identify unique strengths and needs. Then, the individual and the therapist identify the type of treatment that best meets the need. The assessment process is required by most payers to determine what type of treatment can be reimbursed.

HOW MUCH DOES TREATMENT COST?

Each individual's financial responsibility is based on the assessed level of treatment needed and available insurance coverage. DCCCA staff will help identify specific costs and payment sources. A sliding fee scale, based on an individual's income, is used for people who pay out of pocket for their services.

HOW CAN I AFFORD THE COST OF TREATMENT?

Treatment costs are covered by most insurance companies and Medicaid. Our staff will verify insurance benefits and provide information about the insurance company's requirements. DCCCA will also help refer to an alternative treatment provider if an insurance company does not reimburse for DCCCA services.

DCCCA receives federal and state dollars that cover treatment costs for certain Kansans who do not have insurance or Medicaid. Eligible individuals must prove they are Kansas residents and have an income at 200% or below the federal poverty level.
