

### Course Overview

The 2023 Kansas Opioid and Stimulant Conference is designed to provide participants with a comprehensive understanding of the prescription drug, opioid, and stimulant crisis in the state of Kansas. Through engaging sessions and expert-led discussions, attendees will gain awareness of the multifaceted impact of these substances on individuals, communities, and public health. This conference is a project of DCCCA Prevention Services and the Kansas Prescription Drug and Opioid Advisory Committee and is funded by the Kansas Department for Aging and Disability Services through the State Opioid Response Initiative and the Kansas Department of Health and Environment Overdose Data to Action Initiative.

### Target Audience

This conference is designed for medical doctors, nurses, health care providers, pharmacists, prevention specialists, community coalitions, public health professionals, educators, legislators, treatment providers, addiction specialists, social workers, psychologists, law enforcement, emergency medical services, and all others with an interest in the opioid crisis in Kansas.
