She creates hysterically honest content about motherhood, her experience with opioid addiction, recovery, marriage, and life.

A highly sought-after speaker, Jenkins has completed a 40 city-wide speaking tour where she speaks about addiction, recovery, and her struggles with depression and anxiety. From jails to high schools to recovery events, she shares her own personal experiences with addiction and recovery.

In her memoir, *High Achiever: The Incredible True Story of One Addict's Double Life*, Tiffany Jenkins provides an up-close portrait of the mind of an addict and the devastating effects of narcotics. The book takes readers inside the distress of addiction by detailing her life as an active opioid addict, her time spent in jail, and her eventual recovery and subsequent journey into motherhood. By combining captivating honesty with her signature humor, Jenkins puts a human face on the opioid crisis.

In addition to running her blog and speaking about her experience with addiction, Tiffany Jenkins co-hosts *Take It or Leave It*, a parenting podcast that tackles marriage, motherhood, and everything in between. She has over 9 million followers across her social media platforms and has amassed over a billion total video views.



Kansas Opioid and Stimulant Conference

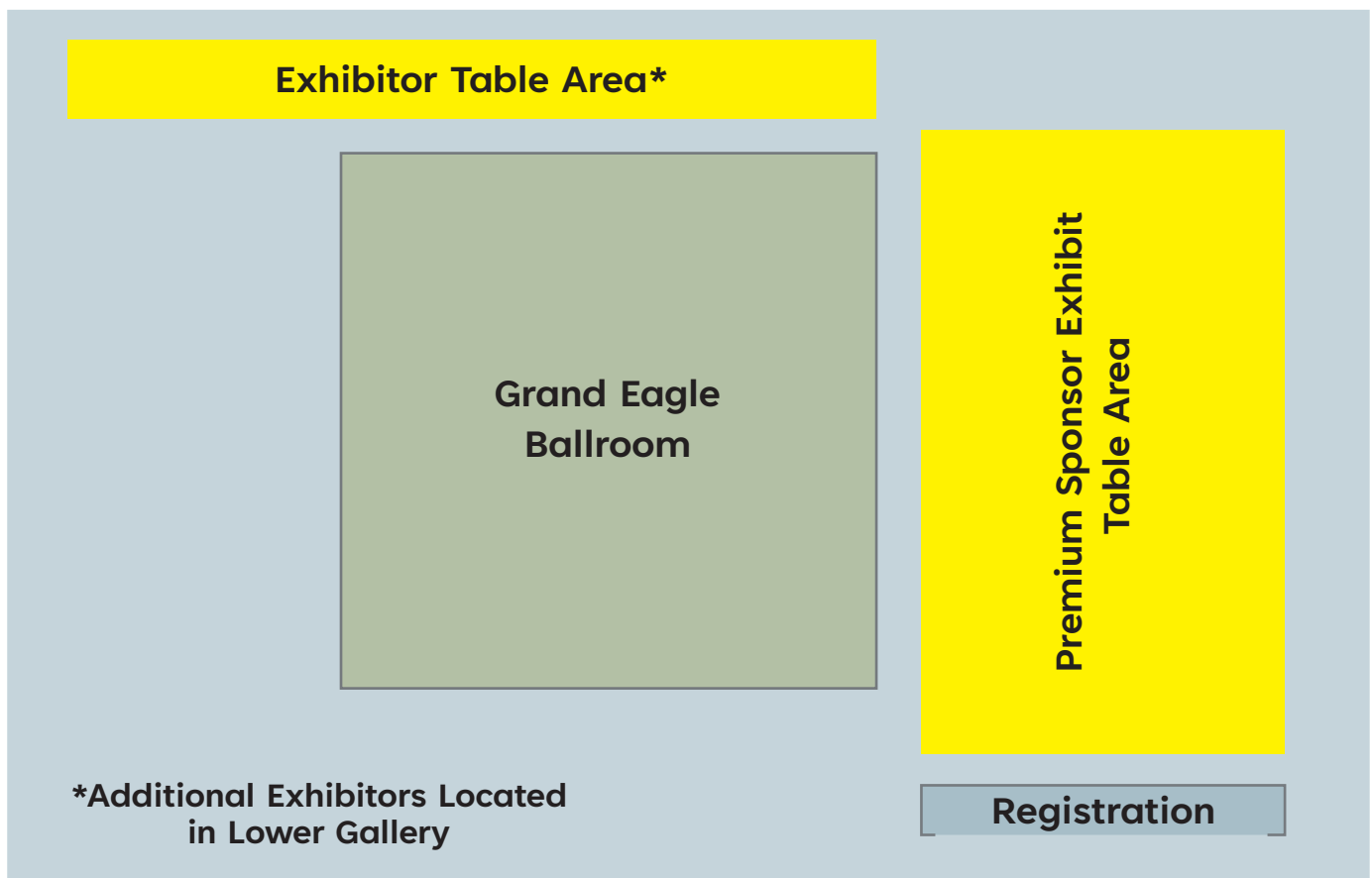
