Our Impact

Celebrating 40 Years

On April 10, 2014, DCCCA celebrated 40 years of providing services to communities. The agency began in Lawrence, Kansas as a small grassroots organization focused on alcoholism with two staff members and a budget under \$10,000. Today, DCCCA conducts business in five distinct service areas - behavioral health, child placing agency, community and family services, youth residential services and traffic safety - and has nearly 230 employees in 12 locations in Kansas and Oklahoma.

Child Placing Agency

DCCCA began operating as a child placing agency in Oklahoma in August 2013. At the end of the fiscal year, our agency had [114 resource families](#) in Oklahoma providing foster homes for [153 children](#). In Kansas, our child placing agency served [286 resource families](#) providing homes to [428 children](#). We also implemented a new data base, Kaleidacare, that allows foster parents access to their own family and child records to provide better support to children in their care.

Youth Residential Services

The Youth Residential Center in Pittsburg, Kansas served [130](#) youth ages 12-18 who were placed in the custody of the state for temporary out of home placement. Youth were taught cognitive behavioral approaches to facilitate change and prevent recidivism. All interventions assist residents to meet their full potential and improve behavior to support a successful transition back to their family and community.

Behavioral Health

DCCCA maintains five licensed substance use disorder treatment programs located in Lawrence, Wichita and Pittsburg, Kansas. In addition to our programs, DCCCA offers behavioral health services in primary medical care clinics and mental health settings. During FY14, DCCCA facilitated [2,726](#) unique admissions to our behavioral health programs. Of the clients completing surveys when exiting treatment, 95% reported that they were satisfied or very satisfied with treatment services and 79% reported that

their treatment experience at DCCCA was better than other programs.

Trauma Informed Learning Community

The National Council for Behavioral Health selected DCCCA as one of 27 organizations nationwide to participate in their Trauma Informed Learning Community. The learning community offers evidenced-based tools, technical assistance and access to national experts and information as DCCCA evolves into a trauma informed workforce, service provider, and community. Through this process, DCCCA is—

- enhancing screening and assessment processes
- focusing on consumer driven care
- educating and nurturing staff
- implementing evidenced-based practices
- creating safe environments
- developing ongoing performance improvement and evaluation workflows

Kansas Traffic Safety Resource Office

The mission of KTSRO is to provide public information and education to protect Kansans from avoidable injury or death on Kansas roadways. This fiscal year KTSRO distributed [581,315](#) informational materials across the state. KTSRO also facilitates the Seatbelts Are For Everyone (SAFE) program. SAFE has spread to [118 schools in 55 counties](#), reaching [60,000 teens](#). During the past six years, seat belt usage has increased 12% in participating schools and seat belt usage among 15-17 year olds increased from 61% to 83%. DCCCA received funding from the Oklahoma Highway Safety Office to complete a SAFE pilot in the upcoming year.

Research and Evaluation Services

DCCCA completed the second year of a five year contract to conduct the Kansas Statewide Summer Occupant Protection Observational Surveys ([35 counties, 544 sites](#)) and the Statewide Direct Observation Child Passenger Safety Seat Surveys ([20 counties, 398 sites](#)). This year was dedicated to converting the survey system to an electronic version utilizing tablets for data collection, downloads and analysis.

Regional Prevention Center

The prevention center implemented the *It Matters* campaign across eight counties in Northeast Kansas. *It Matters* and related educational campaigns are sponsored by Kansas Behavioral Health Services which helps communities understand the extent and cause of substance abuse problems and take action to reduce and prevent them. The prevention center helps coalitions select proven prevention strategies and seek resources to reduce underage drinking.
