DCCCA Specialists recruit, train, and provide 24-hour support for foster families across Kansas.

Family Preservation

DCCCA delivers specialized in-home services to families to build on family strengths and reduce the risk of children being placed in foster care.

Behavioral Health

Substance abuse residential and outpatient treatment, recovery support services, and outpatient mental health services are provided by DCCCA across Kansas.

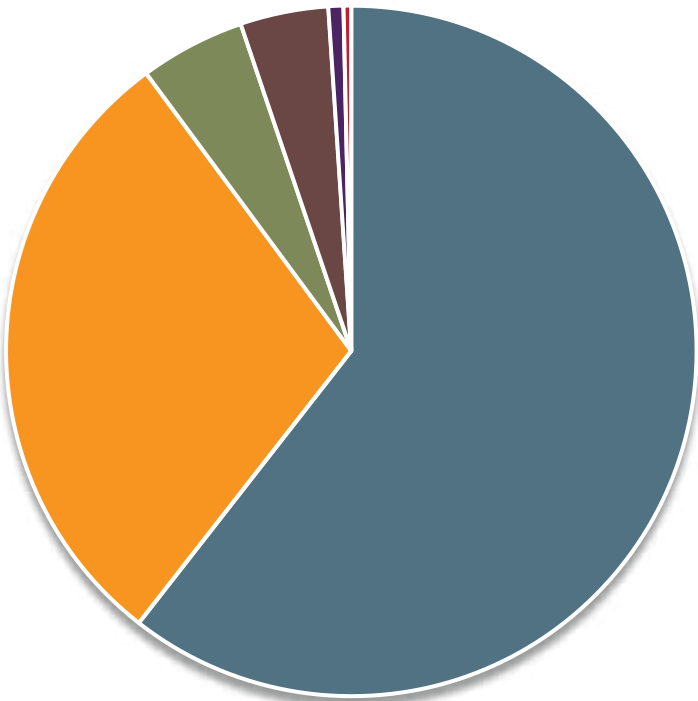

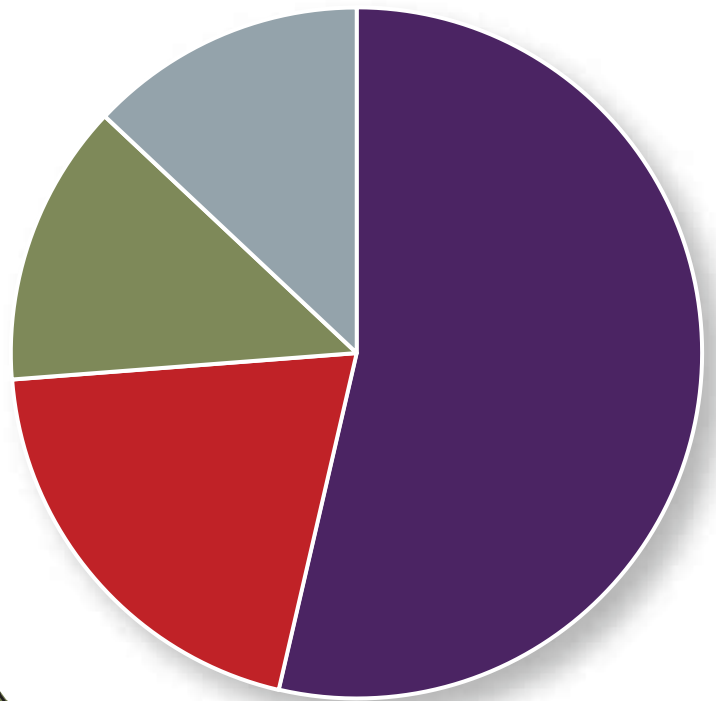

CLINICAL SERVICES

BEHAVIORAL HEALTH

DCCCA has provided behavioral health treatment in Kansas since 1974. DCCCA's substance use disorder treatment programs serviced 2,300 individuals during the fiscal year, 78 children living with their mothers in treatment were served in our licensed childcare, and 85 individuals received outpatient mental health services.

DCCCA's Behavioral Health community collaboration initiatives continued their focus on integration interventions in spite of the pandemic. Peer Support driven access to social detox services from Lawrence Memorial Hospital Health expanded by embedding DCCCA Peers in the emergency department on second shift seven days weekly. Having onsite access increased referrals of those needing substance use services by 25% from the prior year. The Sobriety Treatment and Recovery Teams (START) collaboration with DCCCA Family Preservation resulted in 200 parents referred for a comprehensive assessment and treatment. Finally, new state dollars now allow uninsured individuals struggling with opioids access to life changing, and recovery supporting medications in addition to their treatment interventions.

While numbers served remained steady from last year, the COVID-19 pandemic continued to limit Kansans' access to residential treatment. The Lawrence and Wichita residential facilities continued operating at 60% capacity to mitigate virus exposure and spread. As communities re-opened and fluctuated mask and social distancing mandates, the treatment facilities maintained rigorous safety protocols to protect the health and safety of staff and those served. Outpatient treatment services returned to some in-office service delivery while maintaining virtual interventions through tele-health technology.



CHILD WELFARE

Child Placing Agency

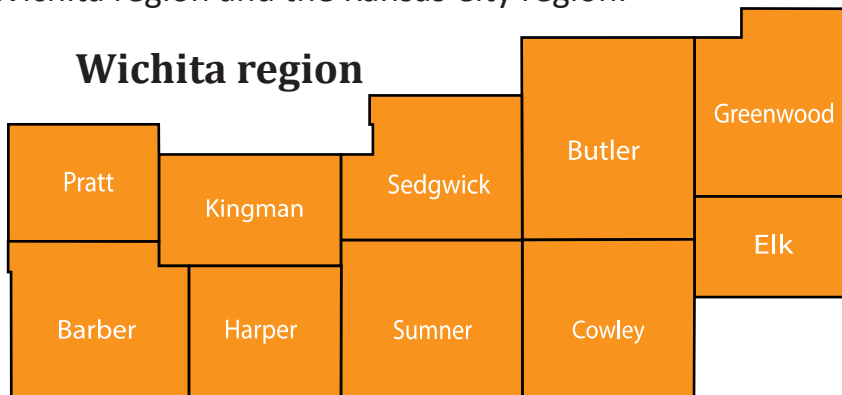
DCCCA has provided Child Placing services since 2002 and Child Welfare services since 1997. DCCCA works with the Department for Children and Families (DCF - Kansas) and the Department of Social Services (Missouri) to recruit, train, and support foster families. CPA specialists recruit, train and provide ongoing support for foster families across Kansas and Missouri. The specialists support foster families through all stages of their placement 24 hours a day, 7 days a week.

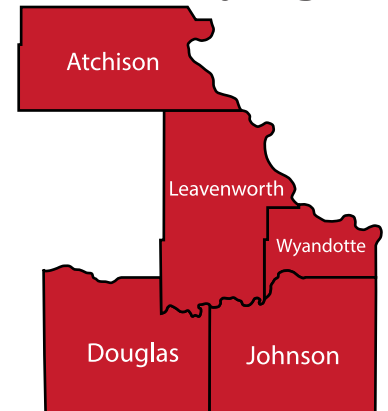
Family Preservation

DCCCA Family Preservation serves two regions in Kansas: the Wichita region and the Kansas City region.

Family Preservation therapists, case managers and family support staff provide in-home interventions to assist families in crisis by improving parenting and family functioning while keeping children safe. DCCCA supports families 24 hours a day, 7 days a week to promote the well-being of children and prevent children from entering the foster care system. DCCCA initially began providing Family Preservation services in 1997. DCCCA provided services to 923 families this year. Community referrals is a pilot project in the Kansas City region allowing families to obtain services outside of having an open case with DCF. Agencies and families can refer families directly to DCCCA.

Foster Family Conference

DCCCA hosted the Foster Family Conference 2021 at Great Wolf Lodge and Children's Mercy Park on April 13-14 in Kansas City. More than 100 foster families attended training sessions to build skills on a variety of topics, while children enjoyed the water park and other on-site amenities. This free conference served as an appreciation event for foster families and provided an opportunity for them to meet fellow foster parents.

COMMUNITY BASED SERVICES

PREVENTION

DCCCA's prevention initiatives span multiple funding streams in two states. Prevention services programs design and develop learning modules and training resources focused on substance abuse prevention, mental health promotion, suicide prevention, and problem gambling prevention. DCCCA also has specific prescription drug and opioid misuse prevention efforts in Kansas and Oklahoma.

In Kansas, DCCCA has two primary projects, a statewide training and technical assistance project and a statewide opioid and prescription drug misuse prevention project. Within this Kansas prescription drug prevention work, contracts with the Kansas Department for Aging and Disability Services and Kansas Department of Health and Environment to collaborate with key stakeholders to maintain and update the strategic plan to address prescription drug and opioid misuse. Also, support is provided for the coordination of Naloxone distribution across the state.

In Oklahoma, DCCCA has three projects addressing different aspects of prescription drug misuse prevention and education. These projects focus on community-based planning and implementation of evidence-based prevention strategies; education focused on medical availability of prescription drugs, emphasizing safe use, storage, and disposal of prescription drugs, and promotion of Naloxone administration.

- Provided training and technical assistance to more than 300 coalitions and community partners
- Virtual Kansas Youth Community Change Conference (KYC3) 157 participants, 22 sessions
- Offered 105 prevention trainings with 104 trainings, 1,737 participants
- Kansas Opioid Conference, more than 355 participants
- Provided 6,531 Naloxone kits to reverse opioid overdoses and save lives
- Implementation of Douglas County Youth Prevention initiatives in all Douglas County high schools
- Received new funding through the federal Drug Free Communities grant, funding to address opioids and stimulants, funding to support a statewide mental health first aid project in Oklahoma
- Virtual Oklahoma County Opioid Summit 199 participants, eight sessions



TRAFFIC SAFETY

DCCCA maintains a partnership with the Kansas Department of Transportation to provide education and safety resources through the Kansas Traffic Safety Resource Office. DCCCA also developed and operates SAFE (Seatbelts Are For Everyone), a teen-run, peer-to-peer program in Kansas, Missouri, and Oklahoma. This program is designed to reduce the number of motor vehicle-related injuries and fatalities among teens and is a proven countermeasure that works to change behavior. Additional grant funding for underage drinking projects and youth programming is also received.

- Updated the OKSAFE website (www.seatbeltsareforeveryone.org)
- Maintained 130 Child Passenger Safety Stations with 575 CPS Technicians and 32 CPS Instructors
- Distributed \$100,000 worth of car seats to the stations for distribution to low SES populations
- Completed 10 Child Passenger Safety Technician training courses, training 62 new technicians across the state
- 4th Annual Kansas Teen Transportation Safety Conference - 280 Teens and Sponsors
- Distributed 520,000 pieces of traffic safety literature
- Updated the SAFE training video to have teens teaching the program
- Completed a SAFE training manual for sponsors and students
